SUBJECT: Amendment to Election Canvass Report

As per our discussion today, we are in the process of preparing an amended election report to correct a Ballot Board error that occurred while sorting the ballots for tabulation. The correction will not change the outcome of the election. The error is the result of ballots being placed behind the wrong header card in precinct 4418. As you know, precinct 4418 is split between Council District 1 (4418A) and Council District 3 (4418B).

The Ballot Board inadvertently placed 39 early voting ballots for precinct 4418B behind the header card for precinct 4418A. This resulted in the ballots being counted in the Council District 1 race instead of the proper Council 3 race. The corrected report will reflect the following:

Rizo 715 (less 23 votes from first report)

Wesson 101 (less 1 vote from first report)

Council District 3

Stimson 1902 (plus 23 votes from first report)

Murphy 1212 (plus 15 votes from first report)
